### Description of the academic discipline

#### 1. The purpose and objectives of the academic discipline

The relevance of the course is determined by the new challenges that are faced by Ukrainian youth today: the formation of an oikumene for life and development, the formation of the Ukrainian state, understanding one's place and role in Ukrainian society.

The purpose of teaching the educational discipline «Ukraine: History and Modernity» is to make future teachers and organizers of primary education aware of the analysis and understanding of the state-building, ethno-cultural and spiritual foundations of the development of Ukrainian society. Mastering knowledge of a wide range of modern educational technologies; improving the quality of training a specialist capable of flexible and mobile construction of professional activity.

The main **tasks** of studying the discipline «Ukraine: History and Modernity» are:

 $\checkmark$  to investigate the patterns of emergence and sources of Ukrainian history formation;

 $\checkmark$  to find out the essential history features and spiritual culture of our people, their humanistic orientation, openness, deep democracy, creative character;

 $\checkmark$  to teach students to operate freely with modern socio-cultural concepts and broad factual material;

 $\checkmark$  to develop the ability to analyze and generalize historical material in a certain system, to evaluate the most important events and phenomena of Ukrainian history;

 $\checkmark$  to compare historical events, to orientate in scientific and historical paradigms of modern times, to develop the ability to find and critically analyze the necessary information from the past and modern Ukraine;

 $\checkmark$  to apply acquired knowledge to forecast modern social processes;

 $\checkmark$  to know their rights, to be able to defend them, to form their own point of view about the surrounding socio-political and cultural-educational processes.

- the main stages of the formation of artistic styles in Ukrainian culture; *be able:* 

- to determine the periods, regularities of the formation and development of ethnopolitical processes in Ukraine based on the results of the analysis of historical sources and historiographical literature;

- to determine the features of the modern socio-political development of Ukrainian society and its perspective by analyzing modern documents and historical documents;

– to perform a comparative and in-depth analysis of historical events and phenomena;

- to understand the interrelationships of the past, present and future;
- to understand and learn from historical experience.

### **CONTENT MODULE 1. Formation and development of the politico**administrative system of Ukraine

### Topic № 1. Introduction to the course «Ukraine: History and Modernity» (1 hour)

Periodization and problematic approaches to studying the history of Ukraine. The problem of studying historical processes of Ukraine in historiography. Polarity and ambiguity of issues of historical development and state formation in foreign historiography: from the side of Poland, Russia, diaspora historiography, countries of Western and Eastern Europe, and the world in general.

### Topic № 2. Formation of Ukrainian statehood: history and modernity (2 hours)

Defining the definition of «statehood» for Ukraine. Elements of the state system in historical retrospect (Paleolithic, Neolithic, Eneolithic, Iron Age). Ancient Rus statehood, elements of the state system among the Cossacks, militarypolitical entity «Zaporozhya Army», Hetmanship, imperial administration in Ukrainian lands early XIX, XX century State-building processes during the Ukrainian revolution of 1917-1921. Attempts to destroy Ukrainian statehood during the times of the USSR, processes of systemic disintegration during perestroika, state-building processes in independent Ukraine. Modern prospects for the development of the system of Ukrainian state.

### Topic $\mathbb{N}_2$ 3. Development of self-government in Ukraine: history and modernity (1 hour)

Defining the definition of «statehood» for Ukraine. Modern intelligence about the Ukrainian mindset, changing the archetype of a Ukrainian.

Xenophobia in modern Ukraine: forms and manifestations, ethnophobia against Ukrainians in the world.

Religious denominations in modern Ukraine: Buddhism, Christianity, Islam, Judaism, paganism, Gaudiya-Vaishnavism, religions of national minorities, etc.

Labor emigration from Ukraine: causes and consequences.

### 5. Teaching methods:

#### General:

1. **Verbal** methods of learning: heuristic conversation; achromatic explanation (induction, deduction, tranduction), story, lecture, instruction, work with a textbook.

2. Visual teaching methods: illustration, demonstration, self-observation.

3. Практичні методи навчання: вправи, практичні й дослідні роботи.

4. Active teaching methods: Socratic conversation, discussion, cooperative learning, simulation-activity games, psychodrama, case study (method of situations).

5. Methods of information and telecommunication technologies: LMS (Learning Management System) software applications for the administration of training courses within the framework of distance learning (Classroom, Prometheus, Quizlet, Udemy, EdX, Coursera, Brainly, Khan Academy, CK-12). WhatsApp, Viber, Telegram.

### By the nature of cognitive activity:

1) *explanatory-illustrative* (information-receptive) method: the teacher organizes the perception and awareness of information by the applicants, and the applicants carry out perception (reception), reflection and memorization of it;

2) *reproductive:* the teacher gives the task, in the process of implementation of which the applicants acquire the skills of the ability to apply knowledge according to the model;

3) *problematic execution:* the teacher formulates the problem and solves it, the applicants monitor the progress of creative search (the applicants are given a kind of standard of creative thinking);

4) *partially-search* (heuristic): the teacher formulates a problem, the gradual solution of which is carried out by applicants under his leadership (at the same time there is a combination of reproductive and creative activity of applicants);

5) *research: the* teacher points out for the applicants a problem, and they solve it on their own, putting forward ideas, checking them, selecting the necessary sources of information, devices, materials, etc.

### 6. Control methods

- assessment of the solution of typical tasks;

- criteria-oriented tests for separate sections of discipline and discipline in general;

- written test papers;

– oral questioning during classes;

- assessment of essays on certain sections of the discipline using monographic and periodical literature;

- remote control;

- final test / offset.

### **CRITERIA FOR ASSESSING KNOWLEDGE AND SKILLS:**

is applied, if the applicant:

- thorough and full reproduces of the studied material;

- shows a complete understanding of the material, justifies their thoughts, applies knowledge in practice, gives the necessary examples not only in the textbook, but also independently compiled;

- reports the material consistently and correctly in terms of the norms of the literary language.

- can apply it to solve specific professional problems.

The assessment «perfectly» is applied to applicants who have learned the relation between the basic concepts of discipline and profession, which they acquire, discovered creative abilities and use them during the study of educational and software material. An excellent level corresponds to the correct and exhaustive answer to the question posed, in which the applicant showed a comprehensive systemic knowledge of the software; mastering the basic and additional literature; clear command of the conceptual apparatus, methods, techniques and tools, the study of which is provided by the programs of disciplines; the ability to argue their attitude to the relevant categories, dependencies and phenomena.

is applied if the applicant gives an answer that satisfies the same requirements as the assessment «5», but makes some mistakes that they corrects after the comment of the teacher, and single shortcomings in the sequence of presentation of the material and speech design.

The assessment «very good» (83-89 points, B) - above average with several mistakes - is applied to applicants who fully mastered the teaching and programming material, successfully completed the tasks provided by the program, learned the basic literature, which is recommended by the program. The assessment of «very good» is exhibited to applicants who show the systematic nature of knowledge of the discipline and are able to independently replenish their knowledge throughout the training;

The assessment «good» (75-82 points, C) - is applied to applicants who have mastered the teaching and programming material, successfully completed the tasks provided by the program, learned the basic literature recommended by the program; thus, the work of the applicants is done, but with a certain number of mistakes.

is applied if the applicant discovers knowledge and understanding of the main provisions of the topic, but:

- reproduces the material not fully enough and makes mistakes in the formulation of rules;

- does not know how to deeply and convincingly justify their thoughts and experiences difficulties in the selection of examples;

- reproduces the material inconsistently and makes mistakes in speech design.

The assessment «satisfactory» (68-74 points, D) – is applied to applicants who know the main teaching and programming material in the amount necessary for further training and use it in the future profession, perform the task well, but with a significant number of errors, familiar with the basic literature, which is

recommended by the program. Satisfactory level generally equals to the correct answer to the question asked (task), if the applicant showed a sufficient level of knowledge of the basic software material, but failed to convincingly argue his answer, made a mistake in using the conceptual apparatus, showed insufficient knowledge of literary sources. The assessment is «satisfactory» to applicants who made mistakes during the execution of tasks, but under the guidance of the teacher, they find ways to overcome them.

The assessment «enough» (60-67 points, E) - is applied to applicants who know the main educational and program material in the amount necessary for further training and use it in the future profession, and the fulfillment of tasks satisfies the minimum criteria.
